Back in the early days the 'double glazing' industry had a bit of a reputation. Much of it deserved with homeowners losing deposits and often subjected to questionable sales tactics. This was a new industry, building has been around for a very long time. The FMB has a very big clean-up job to do but maybe should be careful what it wishes for. Licensing would undoubtedly involve government and that is seldom a good idea.
